Payment Schedule

Registration fee	Payable within 7 days of issue of offer letter.
Tuition fees	Payable within 7 days of the start of term. Tuition fees can be paid annually or termly. A 5% discount applies for annual payments. A flexible payment plan can be arranged in exceptional circumstances.
Security Deposit and School Development Fund Fees	Payable within 7 days of the start of your child's first term. A flexible payment plan can be arranged in special circumstances.
Fee top-up on moving from Nursery to Reception	For children moving up from Nursery to Reception, the balance of the Registration Fee (ZMW 1000) and School Development Fund Fee (ZMW 3000) is due within 7 days of the start of your child's first term in Reception. Alternatively, you may choose to pay the full registration fee (ZMW 1500) and Development Fund Fee (ZMW 4000) on entry to Nursery.

Terms and Conditions

- a. Registration Fee is payable within 7 days of issue of offer letter in order to secure your child's place.
- b. Termly Tuition Fees are payable within 7 days of the start of term.
- c. Security Deposit and School Development Fund Fees are payable within 7 days of the start of your child's first term.
- d. Tuition fees may be paid in full for the year – a 5% discount applies to annual tuition fee payments.
- e. A flexible payment plan can be arranged in exceptional circumstances.
- f. Non-payment of Tuition Fees will result in pupils not being admitted to school. Pupils may return to school as soon as fees are paid in full.
- g. When your child leaves the school at the end of Grade 7, the Security Deposit will be offset against the final term's tuition fees.
- h. If your child leaves the school before the end of Grade 7, the Security Deposit will be offset against the final term's tuition fees only on receipt of a term's notice in writing.
- i. If you feel your account is incorrectly shown please contact the School Office.
- j. Late payment on all fees attracts a 5% surcharge.
- k. For children moving up from Nursery to Reception, the balance of the registration fee (ZMW 1000) and school development fund (ZMW 3000) is due due within 7 days of the start of your child's first term in Reception.
- l. Parents may choose to pay the full registration fee (ZMW 1500) and Development Fund Fee (ZMW 4000) on entry to Nursery.
- m. Part-time Nursery:
 - i. Minimum booked attendance of two (2) days per week.
 - ii. Booked days do not need to be consecutive.
 - iii. Occasional extra days may be added, billable on a daily pro rata basis (based on 60 days per term), subject to availability).
 - iv. The number of booked days per week may be increased during the year, subject to availability. If a change is made mid term, the termly fees will be calculated on a pro rata basis (based on 60 days per term).
- V. Fees for children enrolling mid-term will be calculated on a pro rata basis (based on 60 days per term).
